Superman and Lex Luthor had conspired to make sure this happened, but a desperate effort by Luthor to free them was ultimately thwarted by the forces of the United States government, who sent the children on a covert mission into a parallel timeline. Instead of being imprisoned at the time, the children

from this parallel timeline had escaped and established a new home in the Dakota Territory of the American Midwest, where they were pursued by US Army forces who had become aware of their existence and were determined to hunt them down. In the course of their adventures, Kal-El and Lara had discovered that their son, Jonathan, was actually a Kryptonian, and that not only had he come into existence after Krypton's destruction but that he had been created in the image of his grandfather, Kal-El himself, who had come to Earth in the solar system's final days. At the end of this volume, the storytellers, Grant Morrison and Chris Sprouse, have set about revealing how this son of their

protagonist has come to embody the Golden Age Superman, and the part that he plays in the story of the New 52 continuity. In addition to showing the many differences between the Superman of the 20th century and the Superman of the 21st, the creative team of Morrison and Sprouse has expanded the established mythology and introduced a dramatic new version of the character. The entire story in this volume, which is titled “The World’s Finest,” consists of a two-issue story in which Superman confronts a gang of villains, led by the supervillain Lex Luthor, who have escaped from a top-secret government facility where they have been kept in suspended animation for several years and are set

loose to wreak havoc in the United States. What makes the creative team's approach in this volume particularly fascinating is the fact that it sets out to demonstrate that Superman is an entirely new character, independent of the character that he first appeared in a half-century ago, who has nothing at all to do with the Superman that we know from past incarnations of DC Comics. Effects of long-term variable frequency (20-50 Hz) pulsed current application (4 mA, 30 min/d, 5 days/wk for 2 months) on Ca, P and 1,25-dihydroxyvitamin D (1,25(OH)₂D) were investigated in Sprague Dawley male rats. Femurs from long-term current-treated animals showed increased Ca and P content when compared with control untreated rats. There was a significant increase in 1,25(OH)₂D production by femoral osteoblasts from long-term current-treated rats.
